- We want to settle your concern as quickly as we can, within two working days if possible. Some solutions take a little longer. But in such cases you will be informed of the further procedure after two working days at the latest.
- We are confident that we will find an appropriate solution also for your concern.

In accordance with Section 29 (1) of the Austrian Securities Supervision Act 2018 (WAG 2018) in conjunction with Article 26 of the Commission Delegated Regulation (EU) 2017/565 and Section 39e of the Austrian Banking Act (BWG) we are required to establish, implement and maintain effective and transparent procedures for the reasonable, prompt settlement of complaints of our customers, and to provide our customers with information about the complaints-handling process.
